



Hunt ID: CO-WDeer-Rifle-BAARRI-RHC-OLLEENC

This is a super DIY Hunt. For only \$1795 you will get 1 of 3 vouchers and access to 7000 Acres in GMU107 for hunting whitetail deer with the season dates 10-26 to 11-5 at the beginning of the rut. This great private land hunt contains 7000 acres of rich farm land in Lincoln County.
The property in two separate pieces is located north of Arriba, Colorado on Interstate 70.

Landowner Vouchers can be obtained from us.

The fields contain Winter wheat, Corn, Millet, CRP, Cottonwood trees, water draws and brushy corners along with other crops commonly used in food plots and make excellent feed for deer because it is green in the fall when everything else is brown, dead and dry. There is also multiple water sources on the properties and adjacent properties keeping the deer in the area. Information sources have lead to the fact that private properties north of the State Wildlife area have been very receptive to hunters as long as they ask for permission before accessing the private property. Many times when the deer are pushed from the Flagler State Wildlife area they go on and bed down in the cover of the private property to the north of the SWA.

Whitetail deer are frequently found across the property and it will be you're to hunt out working out the date schedule with the landowner. The voucher included with the property access is a unit wide voucher so it can be used anywhere in GMU107. There are only a total of 3 Whitetail deer vouchers/Licenses available on this property.

Flagler Reservoir State Wildlife Area is located in Kit Carson county Colorado.

From Flagler Colorado, go 5 miles east on Road U to reservoir.

Flagler Reservoir State Wildlife Area is approximately 570 acres (0.89 sq. miles or 2.31 sq. kilometers) and ranges from 4,677 ft to 4,782 ft in elevation.

This State Wildlife Area offers the following recreational activities:

- Hunting: deer, rabbit, pheasant, dove, duck, goose and turkey.
- Recreation: hunting, fishing, power boating, waterskiing, camping, picnicking, hiking and wildlife viewing.
- Restrictions:
 - a. Boating prohibited during waterfowl seasons except float tubes or crafts propelled by hand, wind or electric motors.
 - b. Boating prohibited if it whitewater wake. Waterskiing permitted Sunday and Monday, June 1 to August 31.
 - c. Hunting limited to youth/mentors. Only 1 mentor per youth.

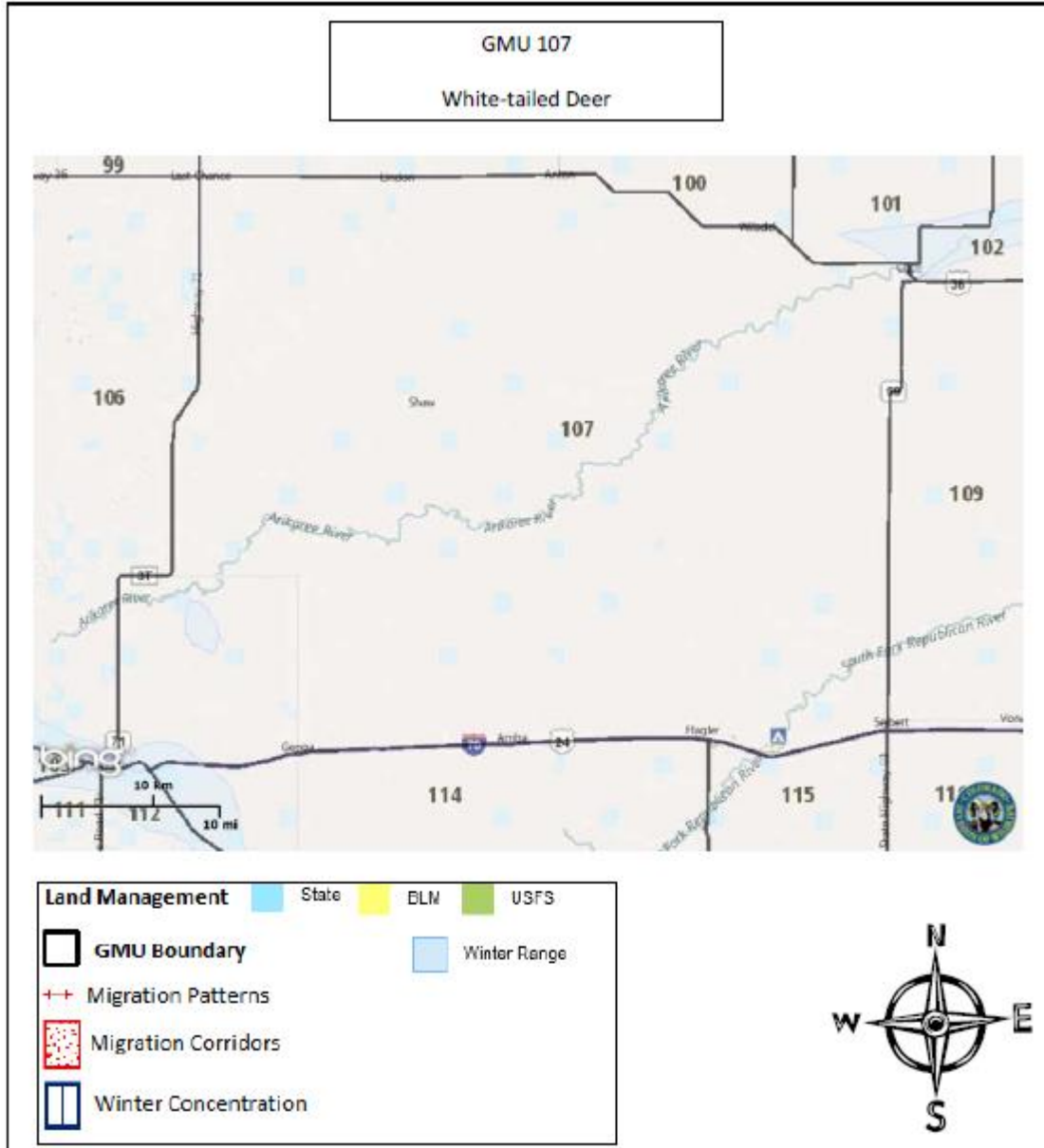
